2. Status and Command Relationships. NAVCONBRIG MIRAMAR DET PEARL HARBOR HI is a shore-based detachment in an active, fully operational status under an officer-in-charge (OIC).

**MISSION AND FUNCTIONS OF  
NAVAL CONSOLIDATED BRIG MIRAMAR DETACHMENT PEARL HARBOR, HI  
(NAVCONBRIG MIRAMAR DET PEARL HARBOR HI)**

**MISSION**

The mission of NAVCONBRIG MIRAMAR DET PEARL HARBOR HI is to ensure administration, security, good order, discipline, and safety of pre-trial and post-trial prisoners from all military Services; to retrain and restore maximum number of personnel to honorable service; and to prepare remaining prisoners for return to civilian life as productive citizens.

**FUNCTIONS**

1. Serve as a Department of the Navy Level I (sentences to confinement up to but not including 1 year) military confinement facility with capability to administer both male and female prisoners.
2. Foster a corrections environment that includes direct supervision, use of the military model, and incorporating a responsibility-based philosophy.
3. Administer core (physical training, recreation, individual counseling, work, academic, incentive life skills, and religious) and Level I (academic education, drug and alcohol education, and crisis intervention) correctional programs.
4. Coordinate access to medical, dental, and mental health programs through local resources.
5. Provide prisoner transportation and escort-custody services as required for pre-trial and post-trial prisoners.
